Ventilation:SUFFICIENT MECHANICAL (GENERAL) AND/OR LOCAL EXHAUST VENTILATION TO MAINTAIN EXPOSURE BELOW TLV.

Protective Gloves:PVA, NITRILE.

Eye Protection:SAFETY GLASSES W/SIDE SHIELDS.

Other Protective Equipment:FULL WORK CLOTHING TO PREVENT REPEATED OR PROLONGED SKIN CONTACT. EYE WASH STATION AND SAFETY SHOWER.
